1/4/22 – One unvaccinated resident was sent to the hospital for evaluation and tested positive at the hospital. Resident was tested negative at the hospital on 12/26/21 and was admitted to the facility on 12/30/21. Resident was tested at the facility upon admission on 12/30/21 and again on 1/3/22 and she was negative both times.
